- 1. The shares being reported are being issued pursuant to restricted stock unit awards ("RSUs"), each one of which represents a contingent right to receive one share of the Issuer's common stock. The shares subject to the RSUs will vest in equal annual installments over a four year period from 08/01/2023, so long as the Reporting Person continues to provide services to the Issuer.
- 2. The shares subject to the nonstatutory stock option ("Option"), under Chimerix, Inc.'s 2013 Equity Incentive Plan, will vest over a period of four years so long as the Reporting Person continues to provide services to the Issuer, with 25% of the shares subject to the Option vesting on 08/01/2024 and the balance of shares vesting in 36 equal monthly installments over the remaining three years.
